

COVID -19 RULES – PAMPOROVO AND MECI CHAL SKI AREA

USING CHAIR LIFTS, FIXED AND MOBILE SURFACE (DRAG) LIFTS AND MAGIC CARPETS

Tourists must cover their mouth and nose during their use of the lifts, when getting ready to mount at the lift stations and in the cash-desk areas, where they purchase their passes and tickets, using a protective mask, scarf, buff or another type of cover. If necessary and at lift operator's discretion, the number of travelers, using an individual seat, may be limited.

Pamporovo AD organizes the scheduled disinfection of the rollbars and seats of the lifts, using products, authorized for use by the Minister of Health for product type 2.

Pamporovo AD organizes the placement of hand sanitizers, approved by the Minister of Health, at specifically marked places, to be used prior to and after using lifts, at the pick-up devices and ski-pass machines, as well as near the cash-desks, selling ski passes and tickets.

At every bottom station of the lifts, there shall be signs showing a face with a protective mask and signs, prompting proper distancing.

Before passing through the turnstiles and before getting on the lifts, corridors shall be made, to prevent crowding of tourists, and the distance between the people in line shall be at least one meter.

USING PAMPOROVO AD'S SKI LOCKERS AND DEPOTS

On the territory of the ski lockers and depots it is obligatory to cover the mouth and nose with a mask, buff, scarf or other type of cover and people, not wearing such protection shall not be permitted to enter the premises. Any persons, visibly showing disease symptoms, should stay at home or at their respective accommodation and avoid using Company's ski lockers and depots, to ensure proper prevention of the others.

Pamporovo AD shall place hand sanitizers approved by the Minister of Health on designated places, and specifically at the respective entrances/exits of the premises.

Pamporovo AD shall organize the regular, scheduled disinfection of all contact surfaces, such as door-knobs/handles, benches, equipment hand-over desks, using disinfectants, approved by the Minister of Health. At the end of each working day Pamporovo AD organizes thorough disinfection of all premises of the ski lockers and depots, using disinfectants and/or germicidal lamps for complete disinfection of the premises and the ski/snowboard equipment.

When using Pamporovo AD's ski lockers and depots, the equipping of tourists is organized so that a physical distance of 1,5 m between individual users is ensured, with the exception of the members of the same family, and no gathering of many people in the premises will be permitted.

USING PAMPOROVO AD'S SKI SCHOOL

The following strict rules apply to the activity of the ski school:

1. The groups can consist of maximum 10 people;
2. Persons in a visible unhealthy condition are not allowed to take part in the training, and therefore, prior to commencement of the training, a filter will be provided (taking the temperature of instructors, participating in the process, of the ski-school employees and all trainees) ;
3. Relocation of persons from one group to another after the initial formation is not allowed;
4. The training in the ski schools must comply with the requirement for physical distance between trainees and instructors;
5. All participants in the training must wear a protective mask on their mouth and nose, or use a buff, scarf or another cover for that purpose.
6. During training, the distance between trainees (with the exception of the members of the same family) must be at least 1,5 m;
7. For safety reasons, Pamporovo AD recommends the individual form of ski/snowboard training.
